Summary

- The S&P/NZX Composite Investment Grade Bond Index was down **0.03%** in November, while its yield-to-maturity closed at **2.33%**.
- The S&P/NZX NZ Government Bond Index stayed flat, and its yield-to-maturity widened 4 bps to **2.11%**. Among the maturity buckets, the S&P/NZX NZ Government Bond 0-3 Year Index outperformed and rose **0.10%**.
- The S&P/NZX Investment Grade Corporate Bond Index was off **0.10%**, while its yield-to-maturity closed at **2.83%**. The S&P/NZX A-Grade Corporate Bond Index was down **0.09%**, and its yield-to-maturity closed at **2.77%**.
- The S&P/NZX Kauri Bond Index lost **0.01%**, while the S&P/NZX Kauri Bond 0-5 Year Index gained **0.02%**.
- The S&P/NZX NZ Inflation-Indexed Government Bond Index decreased **1.11%** for the month.
