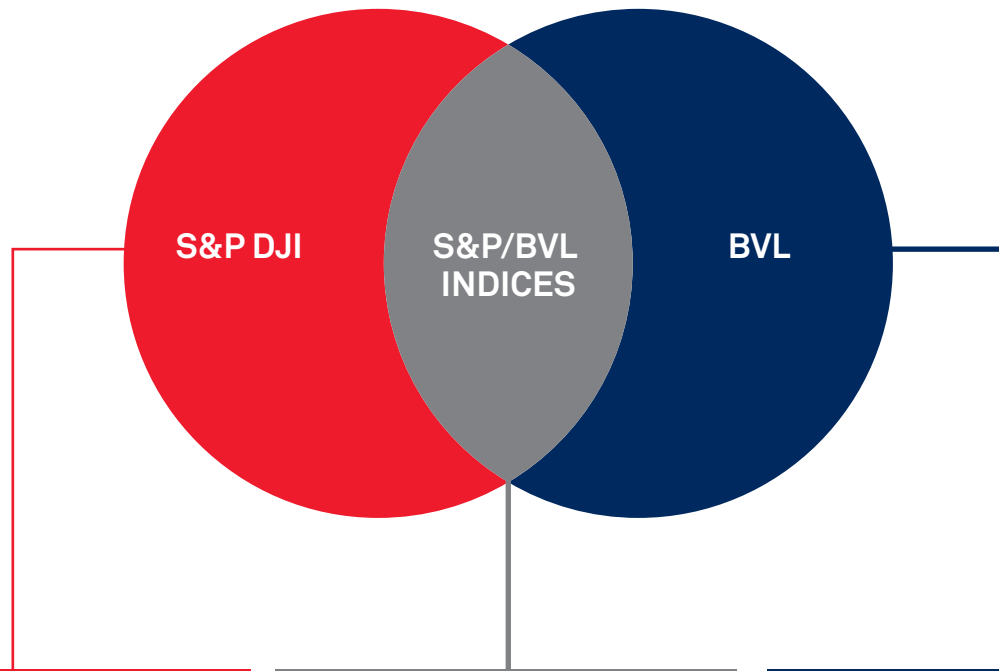

S&P/BVL Index Family

Indices	Description
S&P/BVL Peru General Index	The S&P/BVL Peru General Index is designed to measure the broad Peruvian stock market, using all stocks listed on the BVL that meet eligibility criteria.
S&P/BVL Peru Select Index	The S&P/BVL Peru Select Index is designed to measure the performance of the largest and most liquid stocks listed on the BVL. The index uses the S&P/BVL Peru General Index as its starting universe.
S&P/BVL Lima 25 Index	The S&P/BVL Lima 25 Index is designed to measure the most liquid companies trading on the BVL. Constituents are weighted by their liquidity scores.
S&P/BVL IBGC Index	The S&P/BVL IBGC Index (Good Corporate Governance) is designed to measure the performance of stocks listed on the BVL that are committed to good corporate governance, using a modified market-cap-weighting scheme.
S&P/BVL Peru Dividend Index	The S&P/BVL Peru Dividend Index is designed to measure the performance of S&P/BVL Peru Select Index members that pay dividends using a 12-month trailing dividend yield.
S&P/BVL Peru Sector and Sub-Sector Indices	The S&P/BVL Sector and Sub-Sector Indices are designed to reflect the performance of relevant Peruvian sectors according to the Global Industry Classification Standard (GICS®). The indices, which in some cases are created by grouping different sub-industries, include the following: S&P/BVL Consumer Index, S&P/BVL Construction Index, S&P/BVL Electric Utilities Index, S&P/BVL Financials & Real Estate Index, S&P/BVL Industrials Index, S&P/BVL Mining Index, and S&P/BVL Public Services Index.

Sector Indices:

S&P/BVL Consumer Index

The S&P/BVL Consumer Index is a float-adjusted market-cap-weighted index designed to serve as the benchmark for the Consumer Staples sector of the Peruvian equities market. The index includes companies in beverage, food products, and food & staples retailing, and other related industries.

S&P/BVL Financials & Real Estate Index

The S&P/BVL Financials & Real Estate Index is a float-adjusted market-cap-weighted index designed to serve as the benchmark for the Financials and Real Estate sectors of the Peruvian equities market. The index includes companies in banking, diversified financial services, capital markets, insurance, real estate investment trust (REITs), real estate, and other related industries.

S&P/BVL Industrials Index

The S&P/BVL Industrials Index is a float-adjusted market-cap-weighted index designed to serve as the benchmark for the Industrials sector and Media industry of the Peruvian equities market. The index includes companies representing large local industries such as those in the energy, consumer discretionary, transportation, capital goods, construction materials, and steel industries, as well as those involved in media and entertainment services.

S&P/BVL Mining Index

The S&P/BVL Mining Index is a float-adjusted market-cap-weighted index designed to serve as the benchmark for the Mining industry of the Peruvian equities market. The index includes companies in the diversified metals & mining, precious metals & mining, and other metal industries.

S&P/BVL Public Services Index

The S&P/BVL Public Services Index is a float-adjusted market-cap-weighted index designed to serve as the benchmark for the Utilities industry and Telecommunication Services industry of the Peruvian equities market. The index includes utilities companies, including electricity, gas, water, telecommunication, and multi-utilities companies, as well as companies from the diversified and wireless telecommunications services industries.

Sub-Sector Indices:

S&P/BVL Electric Utilities Index

The S&P/BVL Electric Utilities Index is a float-adjusted market-cap-weighted index designed to serve as the benchmark for the Electric Utilities industry of the Peruvian equities market. The index includes companies that produce or distribute electricity.

S&P/BVL Construction Index

The S&P/BVL Construction Index is a float-adjusted market-cap-weighted index designed to serve as the benchmark for the Construction industry of the Peruvian equities market. The index includes companies in the construction materials, steel, construction & engineering, and building products industries.

S&P/BVL Juniors Index

The S&P/BVL Juniors Index is a float-adjusted market-cap-weighted index that is designed to serve as the benchmark for Juniors stocks in the Peruvian equities market. The index includes companies in the exploration and development stages seeking funding to enable exploration and production of the mines.
